The World Health Organization (WHO) defines '**Disability**' as "an umbrella term, covering impairments, activity limitations, and participation restrictions. Impairment is a problem in body function or structure; an activity limitation is a difficulty encountered by an individual in executing a task or action; while a participation restriction is a problem experienced by an individual in involvement in life situations. Thus disability is a complex phenomenon, reflecting an interaction between features of a person's body and features of the society in which he or she lives."

POLICY DOCUMENT FOR DIVYANGJAN

This document ensures disabled friendly and barrier free environment for divyangjan, so that they live and enjoy equal opportunities like other common people.

1. IPER provides disabled friendly infrastructure like lift and ramp.
2. IPER provides wheel-chairs
3. IPER provides disabled friendly washrooms
4. To ensure barrier free movement and to access the needed facilities freely, signageboards have been installed.
5. College provides scribe for needy students.

INFORMATION BROCHURE FOR DIVYANGJAN

1. College has built lift and ramps in all accessory places where disabled can use easily.
2. College has built disabled friendly washroom, drinking water taps at every floor closer to class rooms.
3. College has placed signage boards for barrier free movement.


